## **Public Health England**

Our chairman wrote to Public Health England asking for details of how the information from the NRPB Study was captured. Some Veterans had been worried that their medical records had been flagged. They were right, Public Health England has a database of the Nuclear participants and check this regularly against the Mortality and Cancer databases held by the NHS. The full response was:

#### Re: British nuclear test veterans

Thank you for your emails received on 14 January 2019 addressed to Public Health England (PHE). Your request for information has been handled under the Freedom of Information Act 2000 (the Act). I can confirm that PHE holds the information you have specified.

I have addressed your request in the order raised:

1) Exactly how has this information been collected, are medical records flagged in some way?

To collect cancer incidence data relating to study participants living in England and Wales the National Health Service number for each individual not known to be deceased is submitted to the English and Welsh cancer registries twice a year for comparison with their records. The registries pass information on cancer incidence back to PHE and this is added to the study database. The system in Scotland is a little different. For Scotlish residents their Scotlish Health Board number has been submitted to National Records for Scotland (NRS) who have flagged the relevant individuals' records. Then when NRS is notified by the Scotlish cancer registry of a cancer incidence for a flagged individual this information is passed on to PHE and added to the study database.

All information about deaths ultimately comes from the Office for National Statistics but for residents of England and Wales this information is obtained via the PHE Office for Data Release. In Scotland the information comes from NRS.

2) Does PHE have direct access to NHS England and the database of births, deaths and marriages?

The study does not directly access information from NHS England. The cancer incidence data in England come from within PHE directly from the National Cancer Registry which is operated by PHE and provided through our Office for Data Release. However, the cancer registries collect their data from the NHS. PHE has an agreement with the Office for National Statistics to access



directly their death data for appropriately approved studies and so that information is also provided to the study team via the PHE Office for Data Release. All our data about Scottish residents comes via National Records for Scotland.

No data on births or marriages are required for the study.

3) If the veteran is now not living in the UK< are the excluded from the study or how is this information collected as in point 1?

Information on study participants is only collected while they are resident in the UK. If they leave the UK no further data is collected and they are recorded as ending their participation in the study at that time.


